3. Validity of the designation

The present designation authorizes the holder, in accordance with article 2, section 2, of the "règlement grand-ducal modifié du 3 février 1998 portant exécution de directives et de règlements de l'Union européenne relatifs à la réception des véhicules à moteur, de leurs remorques et des systèmes, des composants et des entités techniques destinés à ces véhicules, ainsi que des véhicules agricoles et forestiers et des véhicules à deux ou trois roues et des quadricycles" and in accordance with article 2, section 2 of the "règlement grand-ducal modifié du 30 janvier 1983 portant acceptation de certains Règlements annexés à l'Accord concernant l'adoption de prescriptions techniques uniformes applicables aux véhicules à roues, aux équipements et aux pièces susceptibles d'être montés ou utilisés sur un véhicule à roues et les conditions de reconnaissance réciproque des homologations délivrées conformément à ces prescriptions" to carry out specific verifications and tests, as prescribed by the EU directives and regulations as well as by the UN regulations in force, in order to

certify that a type of vehicle, system or equipment meets the administrative provisions and technical requirements related to European and international vehicle type approvals.

In addition, the designation allows the holder to establish technical reports for individual approvals and individuel registrations in accordance with the provisions of Article 3 and 4 of the "règlement grand-ducal modifié du 26 janvier 2016 relatif à la réception et l'immatriculation des véhicules routiers".

Any identification of one or more major non-conformities during an accreditation audit may result in the suspension, withdrawal, or limitation of the scope, or even the validity, of the present designation. This provision also applies in the event of minor non-conformities not corrected within the time limit set by the accreditation authority. Similarly, the loss or suspension of the accreditation on which the designation is based has the same consequences.

The designation may also be subject to suspension, withdrawal, or restriction in scope or validity in instances where serious or repeated violations of the associated conditions and obligations have been committed by the holder. Moreover, such measures may be taken if any of the conditions of the designation are no longer fulfilled. Similarly, failure to comply with all requirements specified in SNCH document F3-05 v.8, the general terms and conditions (currently effective document D-2E, v.7), and the prescriptions for the witnessing of tests by the technical services of category B (currently effective document D1-09, v.2) by the holder may also result in the suspension, withdrawal, or limitation of the designation.

The designation remains valid until 16 April 2027, contingent upon the fulfillment of all applicable requirements and obligations outlined herein.

4. Scope of the designation

The holder is officially designated as a Category B, C, and D technical service to the European Commission and the United Nations Economic Commission for Europe (Inland Transport Committee). This designation adheres to current European and international regulations. The

specific fields of this designation, outlined in Annex I, encompass the following approvals and certifications:

European type approval:

- Motor vehicles and trailers of category M/N/O,
- Motor vehicles and trailers of category L,
- Agricultural or forestry tractors of category T/C/R/S,
- Non-road mobile machinery,
- Components and separate technical units;

International approval of road vehicles:

Concerning the adoption of harmonized technical United Nations regulations for wheeled vehicles, equipment, and parts, which can be fitted and/or be used on wheeled vehicles and the conditions for reciprocal recognition of approvals granted based on these United Nations regulations.

5. Conditions and obligations

Every new EU directive, regulation, or new UN regulation to be included within the scope of designation as specified in point 3 shall undergo a new designation procedure for potential extension of the designation.

The Ministry of Transport reserves the right to request the holder of the designation to carry out or organize additional audits, among others by accreditation bodies, to reassess the scope of the designation in the event of significant changes to an EU directive or regulation, or to an applicable UN regulation (repeal or amendment of a regulatory text).

In this context, it is the responsibility of the Société Nationale de Certification et d'Homologation (SNCH) to define and determine the scope of accredited areas upon which the designation is conferred.

Furthermore, the Ministry of Transport reserves the right to verify or arrange verification at any time, through document inspection or on-site visits, the compliant execution of provisions and obligations of this designation and may demand exhibition of any document or material related to this designation for this purpose.

The holder of the designation is obligated to promptly notify the Ministry of Transport and SNCH of any changes in their circumstances that could impact the validity of this designation.

The holder of the designation is obliged to offer his services in the context of technical approvals in accordance with article 5 (1) of the aforementioned "règlement grand-ducal modifié du 26 janvier 2016 relatif à la réception et l'immatriculation des véhicules routiers".

The designation is strictly personal and is not transferable.
